Oxley established its business presence in the UK with its Royal Wharf project, the 363,000-square metre waterfront township development by River Thames in London. It also acquired a

20% stake in leading UK developer, Galliard (Group) Limited, as part of its strategy to enter into and penetrate overseas markets by leveraging local partner's expertise and network.
