INCREASE IN ISSUED AND PAID-UP CAPITAL OF A SUBSIDIARY

The Board of Directors of Oxley Holdings Limited (the "**Company**") wishes to announce that the issued and paid-up capital of Oxley Pearl Pte. Ltd., a wholly-owned subsidiary of the Company, has been increased from S\$1 to S\$1,000,000 via the subscription of 999,999 new ordinary shares at S\$1 each by the Company.
