INCREASE IN ISSUED AND PAID-UP CAPITAL OF SUBSIDIARIES

The Board of Directors of Oxley Holdings Limited (the "**Company**") wishes to announce that the issued and paid-up capital of each of Oxley Topaz Pte. Ltd. and Oxley Amethyst Pte. Ltd., both wholly-owned subsidiaries of the Company, has been increased from S\$1 to S\$1,000,000 via the subscription of 999,999 new ordinary shares at S\$1 each by the Company.
