Singapore, 3 May 2016 – Oxley Holdings Limited, 豪利控股有限公司 (“Oxley” or “the Company”), homegrown lifestyle property developer, today broke ground for its second Cambodian development, *The Peak*, a mixed-use development in Phnom Penh, Cambodia, followed by a ribbon-cutting ceremony for the showroom opening. *The Peak* is expected to be completed in 2020.

The groundbreaking ceremony was officiated by Guest-of-Honour, H.E. Chea Sophara, Senior Minister, Ministry of Management of Land, Cambodia, who commented that Cambodia, which is politically stable and terrorist-free, and also famous for her amazing natural and cultural tourist sites, is a potential country for investments. Distinguished guests present at the groundbreaking ceremony also included Ambassador of the Republic of Singapore to the Kingdom of Cambodia, Mr. Kevin Cheok, who said, "This ambitious and comprehensive mixed development (The Peak) will further transform the Phnom Penh landscape. It will also offer investors, residents, and tourists another high-end lifestyle option in the heart of the city."

The Peak, occupying a land area of 12,609 sqm and with a gross floor area of approximately 208,750 sqm, is Oxley's second development in Phnom Penh, Cambodia. Once completed, this 55-storey mixed-use freehold development will offer a complete suite of convenience and lifestyle choices to residents and office users.

The Peak will feature two residential towers with a total of 1,014 units, one commercial tower with 15 levels of office units and a Shangri-La hotel with approximately 300 rooms, all sitting above a podium with five levels of retail space. *The Peak* is conveniently located in the heart of Phnom Penh facing the Mekong River and within close proximity to Naga World Hotel and Aeon Mall.

"The Peak is another evidence of our commitment to contribute to property and lifestyle development in Cambodia, particularly in Phnom Penh," said joint-venture partner, Mr. Sear Rithy, Chairman of Worldbridge Land, in his welcome address to the guests. "We focus on improving the living and lifestyle of Cambodians through better infrastructure and lifestyle development," added Mr. Sear Rithy.

"Cambodia remains one of our focused strategic markets," said Oxley's Executive Chairman and CEO, Mr. Ching Chiat Kwong, at the groundbreaking ceremony. "We are also seeking more development opportunities in this promising country while we look to unveil our remaining two developments in Phnom Penh at an opportune time".

Following the official grand opening of the showroom, Oxley will launch the second tower of The Peak Residences comprising another 507 units in Cambodia, followed by Singapore.

Oxley is also looking at launching the development in Hong Kong and Taiwan. To-date, Tower 1 of The Peak Residences, previously launched as Phase 1 comprising 507 units, is almost 50% sold.
